

The authors intersperse problems throughout the book to assist students in understanding and applying the concepts discussed. The book is supplemented annually, and a Teacher's Manual is available to professors.</p>

The book focuses on Supreme Court caselaw, but also covers the Federal Rules and important federal statutes. Important issues of today, including (but not limited to) racial discrimination in police practices, are covered. There is a highly useful Teacher's Manual.
